General Characteristics

How to use it

Sanitizing cleaning: dilute RISANARE FORM 50 ml in 5 liters of water (1:100), wash without rinsing.

Deep cleaning: dilute RISANARE FORM 500 ml in 5 liters of water (1:10), wash and rinse.

Sanitary Cleaning: use RISANARE FORM pure with a soft sponge and rinse.

Suitable for surfaces: ceramic, terracotta, clinker, stoneware, natural stone, plastic laminates, linoleum, rubber, PVC and painted wood.
